# 4. FIRST AID MEASURES

water while removing all contaminated clothes and shoes. For minor skin contact, avoid spreading material on unaffected skin. For severe burns, immediate medical attention is

**Ingestion** Drink plenty of water. Immediate medical attention is required. Remove from exposure, lie

down. Clean mouth with water and drink afterwards plenty of water. Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Call a physician or

poison control center immediately.
