### 4. FIRST AID MEASURES

#### First aid measures

##### General advice

Immediate medical attention is required.

##### Skin Contact

Immediate medical attention is required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. For minor skin contact, avoid spreading material on unaffected skin. For severe burns, immediate medical attention is required.

##### Eye contact

Do not rub affected area Immediate medical attention is required Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes Keep eye wide open while rinsing Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes

##### Inhalation

Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician or poison control center immediately.

##### Ingestion

Drink plenty of water. Immediate medical attention is required. Remove from exposure, lie down. Clean mouth with water and drink afterwards plenty of water. Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

##### Self-protection of the first aider

Use personal protective equipment as required. Avoid contact with skin, eyes or clothing. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

**Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

Dam up. Take up mechanically, placing in appropriate containers for disposal. After cleaning, flush away traces with water.
